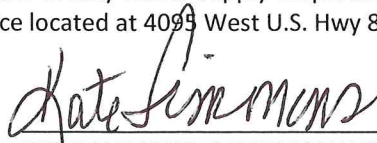

Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda.

Individual members of the public may further address the Board for a maximum of three minutes per person per agenda item and may collectively address the Board for a total of thirty minutes per agenda item. Individuals may address the Board once per item.
